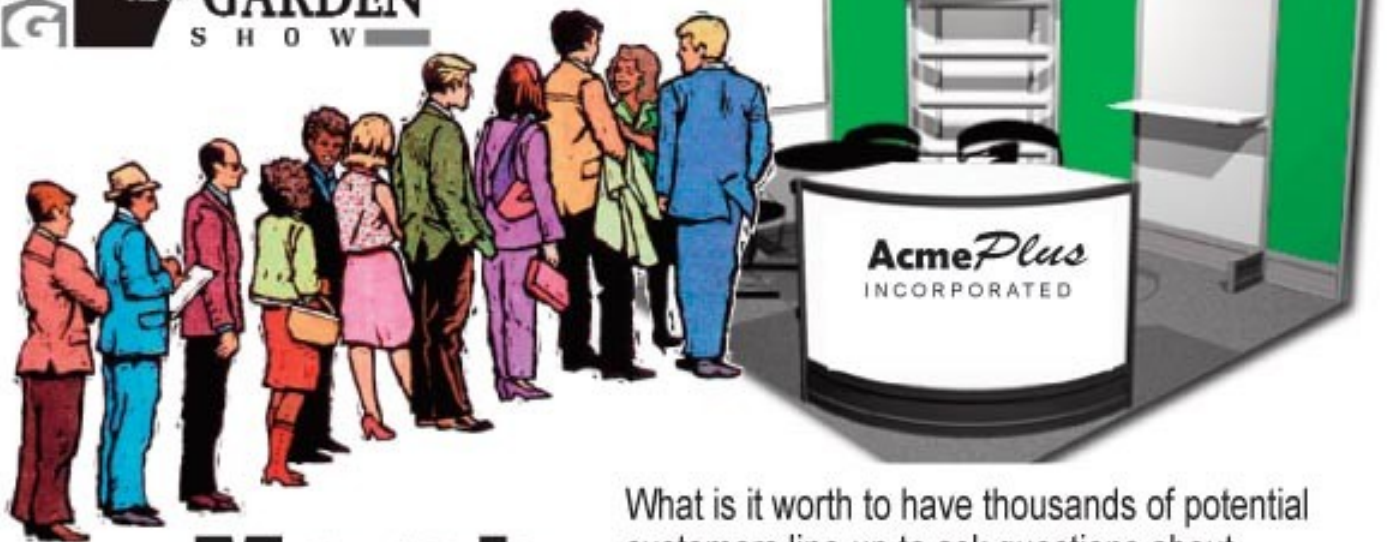
Are You Interested in Attending an OSHA Fall Protection Seminar?
